

Subject: Budget Ordinance to Appropriate Undesignated Reserves from the General Fund for Civic Stadium Turf Replacement

Summary Statement: The artificial turf at Civic Stadium, installed in 2000, has exceeded its lifespan & must be replaced for both safety & playability. In 2006 the City entered into a 20-year Facility Use Agreement with Western Washington University whereby WWU agreed to pay an annual amount to the City for use of Civic Stadium & to help pay for Civic Stadium improvements. As a result, \$180,000 has been received from WWU to date. Staff recommends that these funds be used to offset the cost of the replacement of the turf at Civic. Bids were opened on June 17 with a lowest responsive, responsible bid of \$399,904.03. A budget ordinance is required to appropriate the WWU funds for expenditure for this project which is scheduled to begin construction on July 22.

Previous Council Action: 2000 Civic Turf Installation budget approval and bid award, 2006 Civic Athletic Complex Improvements budget approval and bid award.

Fiscal Impact: The total estimated cost of the project is \$480,000, which includes bid document preparation, construction, sales tax, project administration & contingency. \$180,000 funds from WWU will be used first, with the remainder coming from Beyond Greenways. Remaining Greenway funds can be used for other needed projects.

Funding Source: \$180,000 General Fund revenue from WWU; \$500,000 2013 budget in Beyond Greenway fund
