Subject: Budget Ordinance to amend the 2013 Budget appropriating \$30,000 from Estimated Ending Undesignated Reserves in the Golf Course Fund to pay for repairs and maintenance at the Golf Course.

Summary Statement: The 2013 Golf Course Repair/Maintenance to Structures line item includes \$90,000 budgeted in 2013 and \$30,000 in carry-over from 2012 (cart path patching and pump station repairs). The cart path patching cost was \$23,289 and the repairs to the pump station totaled \$15,717, for a year to date total of \$39,000. To complete the Wash Bay Equipment Facilities in 2013, an additional \$30,000 will be appropriated from estimated ending undesignated reserves.

Previous Council Action: Approval of 2013 Golf Course Enterprise Fund budget

Fiscal Impact: Current Golf Course Enterprise Fund balance is \$220,442, after year end expenditures and additional revenues, the projected cash fund year-end balance would be \$173,351.

Funding Source: Golf Course Enterprise Fund Estimated Ending Undesignated Reserves
