Subject: 2013 Budget Ordinance Reclassifying a Police Deputy Chief position back to a Police Lieutenant position.

ORDINANCE NO. _____

AN ORDINANCE RELATING TO THE 2013 BUDGET RECLASSIFYING ONE POSITION IN THE POLICE DEPARTMENT, GENERAL FUND, WHERE NO ADDITIONAL APPROPRIATION OR REALLOCATION OF EXPENDITURES IS REQUIRED.

WHEREAS, the Bellingham Police Department requested a reclassification of one vacant Deputy Police Chief position to Police Lieutenant in order to better meet the needs of the department.

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Effective September 1, 2013 one position of Deputy Police Chief, Plan E, in the Bellingham Police Department Administration Group is hereby deleted. Effective September 1, 2013 one position of Police Lieutenant, at the salary rate specified in the Fraternal Order of Police labor agreement, is hereby created. There is no additional appropriation or reallocation of expenditures needed as a result of this reclassification, and there is no change in FTEs.
