Subject: Padden Creek Daylighting - 20th Street Permanent Closure, EV-0004

Summary Statement: The Padden Creek Daylighting project will daylight the creek into a natural channel approximately 2,600 feet long of open channel habitat. The City of Bellingham proposes to permanently close the block of 20th Street between Wilson Avenue and Old Fairhaven Parkway. The land will become part of the new creek, riparian corridor and a bioretention swale for stormwater treatment. Permanent closure of this block will eliminate the need for a culvert bridge and assist in the channel placement of the natural watercourse. A public hearing has been scheduled for Monday, September 16, 2013.

Staff Report 20th Street Permanent Closure Between Wilson Avenue and Old Fairhaven Parkway Padden Creek Daylighting - EV-0004

City Council Hearing Date: September 16, 2013

Purpose:

Consideration of closing 20th Street between Wilson Avenue and Old Fairhaven Parkway to traffic in conjunction with the Padden Creek Daylighting Project.

Background:

Padden Creek is a perennial stream in the southerly portion of Bellingham. In the 1890's, a portion of the creek was enclosed in a 2,600-foot-long tunnel. The tunnel cross section is 4 feet by 6 feet and is egg shaped. The tunnel contributes to the degradation of Padden Creek's water quality by eliminating natural riparian buffers, the stream's interconnection to interflow and groundwater, and the stream's natural morphology and biological integrity as well as acting as a barrier to fish passage. Various species of fish, including steelhead, cutthroat trout, chinook salmon, coho salmon and chum salmon utilize Padden Creek. The daylighted channel will also serve as a continuous wildlife corridor through the residential area.

The project will daylight the creek into a natural channel approximately 2,600 feet long of open channel habitat and will leave the tunnel intact to protect the new channel from high erosive flows and allow the project to alleviate flooding upstream during extreme flow conditions. WSDOT is currently undertaking construction of the future creek crossing at SR11 (Old Fairhaven Parkway) with a bridge and temporarily closing this block of 20th Street due to placement of a traffic by-pass around the construction zone.

Permanent closure of this block of 20th Street will aid in the channel placement leaving a natural watercourse in place of a culvert bridge.

Review:

There are several issues that need to be examined when determining whether 20th Street should be closed to vehicular traffic between Wilson Avenue and Old Fairhaven Parkway.

Traffic Volumes

As 20th Street is a residential street, specific vehicle count information is not available, however, information is available for the surrounding principal and secondary routes. Recent traffic volume counts for this area show 24th Street in the block north of Old Fairhaven Parkway having 2,500 vehicles per day. Donovan Avenue to the north carries a volume of 1,400 vehicles per day, and 21st Street north of Donovan Avenue shows a traffic volume of 2,400 vehicles per day. For comparison, Old Fairhaven Parkway has a volume of 13,200 vehicles per day.

In addition to residential traffic, 24th Street, Donovan Avenue and 21st Street all carry considerable student and staff traffic as they are connections to Western Washington University, which increases their traffic volumes. 20th Street is not a direct collector route to the University, but could be used to access 21st Street from Old Fairhaven Parkway. However, traffic going to and from the interstate would logically use 24th Street or 22nd Street to access 21st Street.

Based on the available data from surrounding streets, a fair traffic volume estimate would be less than 1,000 vehicles per day utilizing 20th Street. 20th Street is a primary route from Old Fairhaven Parkway to approximately 41 residential homes.

Neighborhood Plan

The Happy Valley Neighborhood Plan (Plan) specifically addresses circulation and multi-modal traffic on neighborhood streets as well as the connection with the Padden Creek Daylighting project. The following goals and policies from the Plan are relevant to the closure of 20th Street.

Natural Areas, Parks, and Trails

Happy Valley Goal 1, page 5 - Provide, maintain, and enhance natural open space in the neighborhood.

Happy Valley Policy 9, page 8 - Wetlands should continue to be preserved, acquired, and enhanced in order to protect the many functions they serve, including wildlife habitat.

Happy Valley Policy 10, page 8 - The tunnel and other blockages to fish passage on Padden and Connelly Creeks should be targeted for correction as financial resources become available. If daylighting Padden Creek occurs, strict adherence to stream setbacks and floodplain

regulations are necessary for new development to protect resources and prevent flood damage.

Circulation

Happy Valley Goal 2, page 21 - Happy Valley Neighborhood will preserve its residential character and enhance its quality by discouraging through traffic and automobile usage on residential streets and encouraging a development pattern that is pedestrian, bicycle, and transit friendly.

Happy Valley Policy 27, page 30 - In low density areas, street improvements should focus on improving pedestrian and bicycle safety.

Utilities

Happy Valley Policy 41, page 36 - Identify specific areas in the neighborhood where drainage improvements are needed and find a funding source for them. Natural drainages such as Mill Creek west of Connelly Creek should be retained wherever possible, recognizing their stormwater treatment functions and importance to the neighborhood.

Happy Valley Policy 42, page 37 - Adopt new strategies that improve the way stormwater is managed and reduce impervious surfaces as a preventive measure. Identify lands that may be jointly purchased and developed for storm-water treatment purposes.

Cost

While cost will not be the overriding factor in analyzing the impacts closing 20th Street will have to the community, it is something that must be addressed as it has implications for the Padden Creek Daylighting project budget which is comprised of public funds. Should 20th Street remain open to vehicular traffic, a fish-passable culvert bridge would need to be constructed. A similar culvert bridge is proposed to be built at 22nd Street as part of the project. The dimensions of the culvert are 22 feet wide by 4 feet tall by 75 feet long with an estimated construction cost of \$238,000 based on the preliminary construction cost estimate. It can be assumed that the cost of a culvert bridge at 20th Street would be similar.

In addition to the culvert bridge, the sidewalk pedestrian curb ramps at the intersection with Old Fairhaven Parkway would be required to be brought to Americans with Disabilities Act (ADA) standards. Due to the slope of 20th Street, these ramps would be fairly significant and expensive. Should 20th Street be closed, the sidewalk along the

north side of Old Fairhaven Parkway would be extended across the 20th Street right of way, eliminating the need for expensive ramps. A conservative estimate for all-inclusive additional costs for 20th Street to remain open to vehicular traffic would be approximately \$350,000.

Safety

Past safety at the intersection of Old Fairhaven Parkway and 20th Street is not a significant consideration for closing 20th Street. In the past nine years, there has been only one accident recorded at the intersection. However, in conjunction with the Padden Creek Daylighting Project, WSDOT is building a bridge on Old Fairhaven Parkway to the west of the 20th Street intersection. The bridge guardrails may restrict sight distance for vehicles turning onto Old Fairhaven Parkway due to the slope of 20th Street.

The Bellingham Fire Department sees minimal impacts to response times for emergency vehicles. Fire and ambulance services would primarily respond from Station #2, which is located off of Harris Avenue, or would respond from their previous call, which could be anywhere in the area.

Public Input:

In preparation of the discussion to close 20th Street to vehicular traffic, an open house was held on June 4, 2013 to present the design to date to the community and to solicit comments and feedback about the design. Forty-one people were in attendance. In addition, 137 postcards were sent on August 20, 2013 to all property owners who are within a 500 foot distance from any portion of the Daylighting project, requesting feedback specifically on the 20th Street closure. As of September 3, 2013, twelve comments were received. Of those twelve, six were in favor of the closure, four were against it, and two requested additional information. The comments received are attached to this staff report.

Conclusions and Recommendations:

20th Street between Wilson Avenue and Old Fairhaven Parkway is a lightly used residential street that is used as a primary access to approximately 41 residential properties. Other access options to Old Fairhaven Parkway would route traffic less than ½ mile to 22nd Street or to Donovan Avenue.

The closure of 20th Street to aid in the Padden Creek Daylighting Project is within the goals of the written Happy Valley Neighborhood Plan and the desires of the residents. The plan emphasis is on environmental preservation and expansion of habitat and

wetlands as well as stressing mode shift from vehicular transportation to bicycling, walking and public transit.

Where collisions are currently rare at this intersection, a reduction in sight distance from the guardrails of the new bridge may decrease the safety of this intersection. Maintaining 20th Street as it is now, will also substantially add to the cost of the Daylighting project.
