Effective September 1, 2013 one position of Evidence and I.D. Supervisor, Plan C Grade 32, in the Bellingham Police Department Investigations Group is hereby deleted. Effective September 1, 2013 one position of Police Sergeant, Plan C Grade 32, is hereby created. No additional appropriation or reallocation of expenditures is required as a result of this reclassification, and there is no change in FTEs.
