Subject: Bid Award 63B-2013 for Police Uniforms

Summary Statement: Bids were received to supply uniforms to Bellingham Police Officers. The number of solicitations viewed totaled 18 and 3 were received. The uniforms were divided into 19 separate items. The bid submitted by Uniform Warehouse from Chatsworth, Cal was the lowest bid on all items, however bid specifications for 63B-2013 were not followed. The bid submitted by Bratwear from Fife, WA was next, however they only bid on eight of the 19 items. The bid submitted by Blumenthal Uniform Co., was the highest of the three bids, bidding all items to specifications and requirements of 63B-2013.

Previous Council Action: New Bid Submittal for 2013

Fiscal Impact: The bid by Blumenthal Uniform Co for all items was \$54,807.79. This bid includes WA sales tax
