**Subject:** An ordinance repealing Bellingham Municipal Code sections 4.82.010 and 020.

**Summary Statement:** As part of the process to republish the Bellingham Municipal Code (BMC) Legal is reviewing the BMC for antiquated or inconsistent code sections. BMC sections 4.82.010 and 020 are not used and are therefore antiquated. Both sections allow the Police Department to charge for specific services, such as using "lie detectors," providing police escorts for \$20, and allowing the Records Bureau to charge \$1 for "services." The Police Department does not offer these services nor does it charge for them. Staff recommends that these sections be repealed.

**AN ORDINANCE REPEALING BELLINGHAM MUNICIPAL CODE SECTIONS 4.82.010  
AND 4.82.020**

**WHEREAS**, the City of Bellingham recently republished the Bellingham Municipal Code; and

**WHEREAS**, as part of the republishing process the City identified certain sections in the Bellingham Municipal Code that were enacted more than 30 years ago and that are no longer useful; and

**WHEREAS**, the City endeavors to have a code that is up to date and accurate, and

**WHEREAS**, Bellingham Municipal Code sections 4.82.010 and 020 describe certain police services that require the payment of fees; and

**WHEREAS**, the Bellingham Police Department does not perform the services described in the Bellingham Municipal Code sections 4.82.010 and 020 in exchange for the described fees; and

**WHEREAS**, because Bellingham Municipal Code sections 4.82.010 and 020 are no longer used and are no longer accurate they should be repealed;

**NOW THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:**

**Section 1. Bellingham Municipal Code 4.82.010 is hereby repealed in its entirety.**

**Section 2. Bellingham Municipal Code 4.82.020 is hereby repealed in its entirety.**
