

Subject: Appropriation of Funds from Ecology Grant #G1400239 into the SSWU Fund for NPDES Activities and Project Engineering

Summary Statement: This ordinance will appropriate \$170,000 from Ecology Grant G1400239 into the Storm and Surface Water Utility Fund (430) as new revenue. This will be expensed for NPDES activities and project engineering.
