Subject: Budget appropriation for two .5 FTEs in the Police Department

Summary Statement: The Police Department is requesting the addition of one half-time Records Clerk and one half-time Accounting Technician. Addition of these positions will allow greater citizen access to the Police Department lobby and provide internal accounting services needed as a result of the pending reclassification of the current Accounting Technician.

AN ORDINANCE AMENDING THE 2014 BUDGET AND APPROPRIATING AN ADDITIONAL \$57,000.00 IN THE GENERAL FUND TO PROVIDE FOR THE ADDITION OF ONE NEW PART-TIME POSITION IN THE POLICE DEPARTMENT RECORDS GROUP AND ONE NEW PART-TIME POSITION IN POLICE ADMINISTRATION, FROM ESTIMATED ENDING UNDESIGNATED RESERVES.

WHEREAS, the Police Department has requested the addition of one new part-time position in the Police Records Group and the addition of one new part-time position in Police Administration.

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Effective February 1, 2014 one new half-time position of Police Support Services Specialist, Plan B Grade 8, in the Police Records Group is hereby created. Effective February 1, 2014 one new half-time position of Accounting Technician, Plan B Grade 9, in the Police Administration Group is hereby created. There is an increase of .92 FTEs for 2014 as a result of these changes. The source of funds will be credited from:
