Rick Hannam strongly disagrees with any actions taken with regard to landlord licensing.

Gaythia Weis President, Puget Neighborhood Association has concerns about:

- 1. wholesale sewer services outside the city limits. While there are specific problems with specific solutions for Lake Whatcom, she does not feel that the City should be abdicating its' role of oversight and possibly allowing greater numbers of sewer permits; and
- 2. while the grant for proposed work on the Lincoln Street, Maple to Byron Project [AB 20294] along with the proposed student housing behind Fred Meyer are exciting; they do not appear to segue well with regard to the impacts from increased traffic, pedestrians and bicyclists on Lincoln Street and the Lincoln/Maple intersection.
