Subject: Request for new Custodial Maintenance Worker position

Summary Statement: Public Works is requesting the addition of one new full-time Custodial Maintenance Worker I position to address the need for additional work at various facilities to include the Library, City Hall, Museum, and Fire Department buildings. The recent reinstatement of Sunday hours at the Library has also increased the Facilities workload.

Previous Council Action: Adoption of 2014 Budget reinstating Sunday Library hours

Fiscal Impact: The addition of a full-time custodian will add \$48,172 in labor expenses to the Facilities Group with the 2014 revenue coming from fund reserves. Future budget year allocations to departments will be increased to cover the added expense.

Funding Source: PW Facilities Fund

AN ORDINANCE AMENDING THE 2014 BUDGET APPROPRIATING AN ADDITIONAL \$48,172.00 IN THE FACILITIES ADMINISTRATION FUND AND ADDING ONE NEW POSITION IN THE PUBLIC WORKS DEPARTMENT, FACILITIES GROUP, FROM ESTIMATED ENDING UNRESERVED BALANCE.

WHEREAS, reinstatement of Sunday hours at the Bellingham Public Library will increase the workload for Public Works Facilities staff, and

WHEREAS, Public Works has requested the addition of one new full-time Custodial Maintenance Worker 1 position to address the need for additional work at various facilities including the Library, City Hall, Museum, and Fire Department.

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Effective February 1, 2014 one new full time position of Custodial Maintenance Worker 1, Plan B Grade 4, is hereby created in the Public Works Facilities Group. There is an increase of .92 FTEs for 2014 as a result of this addition. The source of funds will be credited from:
