Subject: Reclassification of Office Assistant II to Administrative Secretary in the Public Works Department

Summary Statement: Reclassification of the budgeted Office Assistant II position is necessary to provide sufficient administrative support to the Natural Resources Division. The reclassification better aligns division-level administrative services with the anticipated workload, including working independently on complex assignments, handling sensitive personnel files, establishing policies and procedures, and staffing boards and commissions.

AN ORDINANCE AMENDING THE 2014 BUDGET RECLASSIFYING ONE PART-TIME POSITION IN THE PUBLIC WORKS DEPARTMENT, NATURAL RESOURCES GROUP, AND REALLOCATING EXPENDITURES IN THE STREET, WATER, AND STORMWATER FUNDS TO PROVIDE FOR THE ADDITIONAL COST.

WHEREAS, the Public Works Department has requested reclassification of a vacant position in the Natural Resources Group, and

WHEREAS, Public Works further requests a reallocation of existing expenditures to provide funding for the reclassification so that no additional appropriation is required.

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Effective January 1, 2014 one part-time position of Office Assistant 2, Plan B Grade 6, in the Public Works Department is hereby deleted. Effective January 1, 2014 one part-time position of Administrative Secretary, Plan B Grade 9, is hereby created. There is no change in FTEs as a result of this reclassification. Expenditures will be reallocated as shown below to provide funding for the additional cost.
