AN ORDINANCE ADDING A NEW CLASSIFICATION TO THE E-TEAM SALARY PLAN AND AMENDING THE 2014 BUDGET BY ADDING ONE NEW POSITION IN THE POLICE DEPARTMENT, POLICE DISPATCH OPERATIONS GROUP, WHERE NO ADDITIONAL APPROPRIATION IS REQUIRED IN THE PUBLIC SAFETY DISPATCH FUND.			
WHEREAS, funds to create a new non-uniformed position in the Police Dispatch Operations Group to replace the currently assigned Police Lieutenant were included in the Public Safety Dispatch Fund in the 2014 adopted budget, and			
<b>WHEREAS</b> , Human Resources has completed the classification process for this position and recommends that it be allocated to a new E-Team classification.			
NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:			
Effective July 1, 2014 the classification of What-Comm Deputy Director is hereby added to the E-Team salary plan in Grade 18. Effective July 1, 2014 one position of What-Comm Deputy Director is hereby created. No additional appropriation is required to provide for the addition of this new position. There is an increase of .5 FTE for 2014 as a result and 1.0 FTE thereafter.
