Whatcom Conservation District Wildfire Risk Reduction Program

- Funding:
 - City funding (new 2021) focused on properties in Lake Whatcom watershed adjacent to city acquisition properties
 - o County funding (started 2019) focused on communities in wildland-urban interface
 - New federal grant (through Coalitions and Collaborative) \$75,000 to broaden program in Whatcom and Skagit Counties

Whatcom County Parks Forest Management Plan for Lake Whatcom Watershed

- Staff contact: Mike McFarlane, Whatcom County Parks and Recreation
- Parks is initiating the consultant selection process in June 2021. The plan will include a fire
 resistance component along with wildlife management, water quality, and forest health. The
 long-term goal is older growth forest conditions, which is a fire management strategy in addition
 to providing other watershed health benefits.

City of Bellingham Urban Forest Management Plan (UFMP)

- The focus area is city limits and UGA. A consultant is conducting a wildland-urban interface (WUI) analysis.

- Every five years, Whatcom County submits a Natural Hazard Mitigation Plan for review and approval by the Federal Emergency Management Agency (FEMA).
 - Compiles information from other public agencies/jurisdictions in Whatcom County
 - 2021-2025 plan includes new, updated wildfire risk assessment that is coordinated with the new WDNR map/risk assessment tool (see page 1)
 - o In June 2021 public comments were incorporated and the plan was submitted to FEMA
 - FEMA approves the plan then each agency/jurisdiction adopts and approves their agency-specific portion of the plan
 - County Council adopts entire plan as last step

Whatcom County Climate Action Plan

- Staff contact: Chris Elder, Whatcom County Public Works
- This plan includes a Forestry Chapter that addresses forest health and climate resilience including a wildfire management component.
 - Key relevant strategy states, "Increase forest health, survival and climate resilience through forest management practices that reduce wildfire risk, increase soil moisture and stream flows, and preserve wildlife habitat"
 - Numerous identified actions to improve forest health and reduce wildfire risk

City of Bellingham Climate Adaptation Plan

- This plan overlaps with the City of Bellingham 2021-2025 Natural Hazard Mitigation Plan, which is a section of the Whatcom County Natural Hazard Mitigation Plan. The plan includes a section on wildfire and establishes climate change as a contributor to the increase of wildfires.
 - Identifies actions that can be taken to decrease the potential and impact of wildfire in the wildland urban interface
 - o May seek grant funding to implement actions in the plan

Lake Whatcom Water & Sewer District Wildfire Hazard Planning

- Wildfire has been identified by the District as a natural hazard it should plan for.
- Actions identified within the District's section of the countywide Natural Hazard Mitigation Plan
 include firewise critical facilities (water treatment plants, water reservoirs, water pump stations,
 sewer pump stations, etc.); however, action completion is listed as dependent upon receipt of
 external funding.
