Project Name: Demolition of Hanson Residence

Project Description: Demolition of an existing SFR that is more than 45 years old for the purpose of constructing a new SFR. The Washington State Department of Archaeology and Historic Preservation has determined that the home is not eligible for listing on the National Register of Historic Places, however the home is eligible for listing on Bellingham's Local Register of Historic Places. Pursuant to WAC 197-11-800(2)(g), SEPA review is required for the demolition of buildings that have recognized historic significance. Photo documentation of the interior and exterior and a Historic Property Report for archiving purposes will be provided to the State's Department of Archaeology and Historic Preservation. The new home will be located in the same footprint as the existing and does not encroach closer to Edgemoor Lagoon or Bellingham Bay.
