We collaborate with a wide array of schools and colleges, government agencies, and community organizations. I'm passionate about the public purpose of higher education and see the Arboretum as an excellent example of university-community collaboration. I believe there is great potential for expanding educational programming and multi-organization collaborative projects in the Arboretum. I would love to help support this work by serving on the Board.

Finally, the Arboretum is one of the most important places in my daily routine. I fondly remember running through the Arboretum the morning of my first job interview at WWU in October 2014, and looking out from the top of the tower at what I hoped would be my new hometown. I frequently take walking meetings through the trails with my WWU colleagues, students, and community partners. My runs and walks with my family and friends through the Arboretum have generated many special memories. I would love to help care for this important place so it can enhance the lives of many future generations.
