Public Hearing – DRAFT 2021 CAPER

Samya Lutz provided an overview of the Consolidated Annual Performance and Evaluation Report. She pointed out the projects that were completed in the July 1, 2021 – June 30, 2022 funding year. She also spoke to the individual funding sources and what accomplishments they were able to produce. She noted that projects which were initiated but not completed by June 30th would not be reported in this CAPER.

Comments were heard from one member of the public.

A&F Plan update

Samya Lutz explained why the Administrative and Financial Plan exists and the rationale for making amendments to it. The A&F plan will change in the future to include new sales tax funding.

A subcommittee of CDAB members agreed to meet to comment and make recommendations on the stated funding preferences.

Draft Assessment of Fair Housing (AFH) update

Kate Bartholomew reviewed the survey results and an overview of the participation process with the members, and shared highlights from the data analysis. She then presented the draft Goals & Priorities for the 2023-2027 AFH update, and members provided several suggestions.

The Draft AFH for public comment will be distributed to members at least two weeks prior to the next CDAB meeting, and made available to the public at the same time.

- Presentation on role of non-profit vs role of government entity and ways they overlap and how they differ.
- Balance homeownership and the gap in funding.
- Additional discussion on ways to measure equity.
