# **MINUTES**

# **Presentation on Law Enforcement Legislation** [00:08:12]

Don Almer, Deputy Police Chief, Bellingham Police Department

Don Almer presented on the new legislation regarding law enforcement that came out of the Washington State 2021 Legislative session.

- Nearly 100 bills that were passed touched law enforcement in some way, but most people are focusing on 13 of them. Because it is open to interpretation, different agencies are handling it differently.
- Bellingham Police Department is already in compliance with many of these. Use of force is low for BPD compared to other agencies of similar size in the state.
- House Bill 1054 and House Bill 1310 has changed what responses look like. There is more of a focus on de-escalation, which has caused some delay in response. The Bellingham Fire Department is taking on more calls due to this.
- 2022 legislative session should clarify some of the bills that are more open to interpretation.
- MNAC Members had questions and comments on a variety of topics including: what it means to be an
  accredited agency, how many open positions there are at the BPD, who can own a 50 caliber weapon,
  safety training for Bellingham Fire Department, changes in the biennial budget for the police
  department, and the nationwide difficulties with hiring officers.

# Presentation on Whatcom Racial Equity Commission development process [00:38:00]

Heather Flaherty, Chuckanut Health Foundation; Shu-Ling Zhao, Chuckanut Health Foundation; Kristina Michelle Martens, Chuckanut Health Foundation.

- Shu-Ling Zhao presented on the importance of the formation of a Whatcom Racial Equity Commission beginning with the history of racism in Whatcom County. This commission would convene multiple groups in the community to work on tackling institutional racism. She described the diversity of the members of the working group and what they are working towards.
- The vision for the work group is "People of all races in Whatcom County live, thrive, and belong for who they are, as they are. Without fear. Every day."
- MNAC Members had questions and comments about the following topics: reaching out/partnering with Whatcom Community College, how homeless folks factor into the mission statement, and the hope that this will be shared with the Bellingham school district.
- This group hopes to have recommendations to bring forward to the County and the City for review in the next two months.
